Dr. Michael Sherraden is the George Warren Brown Distinguished University Professor, and founder and director of the Center for Social Development (CSD) at Washington University in St. Louis. Sherraden's research has received widespread recognition for testing innovations and impacts on public policy. He is a leading scholar in asset building, with books including Assets and the Poor (1991), Inclusion in the American Dream (2005), Can the Poor Save? (with Mark Schreiner, 2007), and Asset Building and Low-Income Families (edited with Signe-Mary McKernan, 2008). He is also engaged in research on civic service and engagement, with books including National Service (with Donald J. Eberly, 1982), The Moral Equivalent of War (with Donald J. Eberly, 1990), Productive Aging (with Nancy Morrow-Howell and James Hinterlong, 2001), and Civic Service Worldwide (with Amanda Moore-McBride, 2007). Sherraden has advised heads of state and policy leaders in the United States and many other countries. In 2010, Time Magazine named him among the 100 most influential people in the world. He earned his BA at Harvard University, and his MSW and PhD at University of Michigan.

## **NEIL BOOTHBY**

Neil Boothby is the Allan Rosenfield Professor and Director of the Program on Forced Migration and Health at Columbia University's Mailman School of Public

Health. His research focuses on the long-term consequences of deprivation and danger on child development, and the comparative efficacy of interventions that aim to strengthen the capacities of families and communities to protect young children from harm. In 2012-2014 Dr. Boothby served as the US Government Special Adviser and Senior Coordinator to the USAID Administrator for Children in Adversity. During this time, he led the development of the USG Action Plan for Children in Adversity, which was launched at the White House to guide the government's foreign assistance for vulnerable children in low- and middle-income countries. Boothby has held senior positions with UNHCR and Save the Children, working in low-income, disaster and conflict affected countries. He is also the founding director of the CPC Learning Network, which, through Columbia University, supports a range of research programs and training projects in Africa, Asia and Latin America, and the Columbia Group for Children in Adversity, a non-profit that provides technical support to local groups in Africa and Asia. He has published extensively on risk and resilience among war and disaster affected children, and is also the recipient of a number of awards for his field work, including the International Red Cross Humanitarian of the Year Award for his work on child soldiers; the Mickey Leland Award for his work with refugee children; the United Nation's Golden Achievement Award for Excellence in the Social Sector; and the United States Agency for International Development Award for Outstanding Group Achievement for his intergovernmental leadership on the USG Action Plan for Children in Adversity.

Dr. Fred Ssewamala is a Professor of Social Work and International Affairs at Columbia School of Social Work and the Founding Director of Columbia University International Center for Child Health and Asset Development (ICHAD). Dr. Ssewamala has received continuous NIH funding for the past 10 years, as a Principal Investigator on several grants including Suubi-Uganda (NIMH-funded R21), Suubi-Maka (NIMH-funded R34), Bridges to the Future (NICHD-funded R01, 2011-2016), and Suubi+ Adherence (NICHD-funded R01, 2012-2017), to test the efficacy, acceptability, and impact of innovative economic strengthening and asset-development interventions for HIV/AIDS-affected orphaned and vulnerable children (OVC) and their caregiving families in sub-Saharan Africa. The results of this work have been published in American Journal of Public Health, Social Science and Medicine, Journal of Adolescent Health, Journal of Epidemiology and Community Health, Social Service Review, Children and Youth Services Review, and the International Journal of Social Welfare. Dr. Ssewamala organized the first Global Perspectives Conference on Economic Strengthening and Adolescent Health at the University of Chicago in 2014. Dr. Ssewamala holds a PhD and MSW with a concentration in Social and Economic Development Policy from Washington University in St. Louis.


